## Will Serve

## Application Fee (when a parcel would like a will serve letter/ new service): \$500.00/ parcel

Includes administration fee for office personnel and/or engineer's time up to one hour (phone call, email) to determine if we can serve water to applicants parcel. If it is determined within that hour that we can supply water then no deposit will be required. If it is not determined in that hour that we can serve water and requires more time to do so then a deposit (some of which could be refundable) would be required to move forward.

Service connection fees: LCWD \$5,000 FPPUD \$8,000

### Deposit: \$TBD

Amount equal to or greater than office personal and/or engineer's estimate of how much time they would spend to give applicant an answer of what it will take to serve water to their parcel. If all of the time estimated is not necessary the applicant may receive a partial refund. Regardless of the outcome the applicant will have paid for all office personnel and/or engineer's time.

Example: Office personal and/or engineer estimate spending 5 hours to determine what it will take to serve water to applicants parcel. A deposit of \$1000.00 is set. The applicant pays the \$1,000.00 deposit. The office personnel and/or engineer only spend 3 hours to give applicant an answer. At that point a portion of the deposit could be refunded.

#### **Construction:**

Once we have given the will serve letter to applicant and they have a building permit the applicant has the option to hire their own engineer/ contractor to draw up plans meeting specs provided by LCWD. The applicant can also choose to have LCWD draw up the plans and a new deposit will be required.

Applicant can have a properly licensed, insured and referenced contractor to install line extensions, new facilities, etc. at their own cost per approved plans. The applicant can also choose to have LCWD to install at the applicants expense.

Service connections that do not require any additional facilities, plans or engineering will be installed by LCWD.

All construction would be inspected and signed off by LCWD.
